Executive summary

Introduction

This Outcomes Report details communications and engagement activities undertaken to highlight key construction activities and impacts to stakeholders with a focus on recent activities associated with the Church Street closure that forms part of the Temporary Helicopter Landing Site works. This builds on the many engagement activities that have been delivered as part of this project and is guided by the Communications and Engagement Plan for the RPA Hospital Redevelopment. The report captures collateral, activities and feedback received from notification of construction impacts. The NSW Government has committed \$940 million to the redevelopment of the Royal Prince Alfred (RPA) Hospital to deliver a new hospital building and refurbishment of existing spaces.

To support main works construction activities, regular communications channels and platforms are updated to notify stakeholders of key impacts and upcoming disruptions. The communications team provide regular communications on key disruptions and construction impacts across digital and print platforms, as well as face to face channels including briefings, door knocks and community pop ups.

The communications and engagement plan and approach supports the commencement of main works for the project and ensures stakeholders are informed of the project milestones, construction activities, project plans and next steps. Communications for the project provides the opportunity for staff, stakeholders and members of the public to voice their questions, concerns, and provide feedback.

The construction communications includes engagement with key stakeholders as well as with consumers, staff, neighbours and the community. The construction communications is highly accessible, detailed and is targeted when applicable to different packages of work.

This outcomes report focuses on the package of work aligned with the closure of Church Street as part of the construction activities for the temporary helicopter landing site. The engagement was carried out during May and June 2024.

Construction consultation objectives

The objectives that underpin the approach to communications and engagement for the RPA Hospital Redevelopment are:

- 1. Genuine and meaningful engagement across the lifecycle of the project to ensure local voices inform key outcomes
- 2. Build on critical and long-established relationships to engage in the RPA project
- 3. Garner support for key operational changes required to facilitate the delivery of the project
- 4. Build awareness of the RPA Redevelopment with all internal and external stakeholders
- 5. Demonstrate to staff they are valued partners and that their feedback informs the project
- 6. Ensure accurate, timely and regular information is disseminated to staff and other key stakeholders
- 7. Highlight benefits and drivers for the project, including future health, educational, research and employment opportunities.

Church Street closure communications approach

The RPA Hospital Redevelopment team communications approach for the Church Street closure was split into two separate consultation periods. A range of communications platforms and tools were utilised to ensure staff, consumers and community members we informed and updated on the construction activities taking place. The below tables summarise the communication approach taken for the construction consultation and notice period.

Church Street closure communications report

The activities allowed the project team to encourage feedback and build positive associations with the redevelopment while building awareness of the necessary impacts involved in construction activities. Feedback was encouraged informally via in-person conversations and formally via email, phone, and written correspondence.

Information was provided via multiple channels to ensure a wide audience was reached, which included:

Targeted stakeholders

Emails to staff, consumers and project subscribers

An email from the project inbox was sent to 241 subscribers on 6 May 2024 to notify of the construction activities planned on Church Street and its upcoming closure.

The email included links to the project website for further information and had the initial works notice attached. A follow up email was provided on 13 June 2024 to notify of authority approval received and updated work date.

An all-staff EDM was distributed on 6 May 2024 and 13 June 2024 to continue to keep internal stakeholders information of the upcoming construction impacts.

All communications highlighted the most appropriate contact to direct questions, queries and/or concerns.

Neighbouring stakeholder direct briefing

A formal meeting was offered to neighbouring stakeholders to attend on Wednesday 8 May 2024 from 2.00pm to 2.30pm. The direct briefing was held with stakeholders, contractors and project team. The formal meeting was documented with minutes.

Nearby residents doorknock and letterbox drop

The project team carried out a doorknock on Monday 6 May 2024 along Church Street to speak with impacted residents on the upcoming planned closure. 90 properties were doorknocked. 57 properties didn't answer and a works notice and "Sorry we missed you" flyer was placed in the letterbox. 33 residents answered and were happy to receive

the information, with many expressing positive sentiments about the project. Following the letterbox drop and doorknock, there were two community member enquiries received via voicemail to the project inbox to further discuss the works. Community members were responded to by the project team in agreed timeframes.

Consultation feedback

During the recent activities and engagement sessions, the project team received a range of feedback. The key feedback themes received during consultation are summarised below:

- Impact of construction on nearby residents and insight into best street access and further road closures
- Street parking enquiries and access to impacted residences
- Proposed construction traffic management plan
- Importance of continued stakeholder and community engagement
- Project timeline and timeframe
- Construction noise, dust and vibration

Works notice: Wednesday 15 May 2024 Church Street road closure and detour in place

There will be a complete road closure on Church Street from Carillon Avenue intersection through to Grose Street expected to commence from Wednesday 15 May for a period of approximately four weeks pending authority approvals.

Vehicle access to Church Street and Grose Street will be via Hospital Road and Lucas Street or Mallett Street and Fowler Street. Pedestrian access will be maintained but adjusted at times. Due to insufficient space for a turning circle there will be no street parking available in the closed area. Traffic controllers will be on site to help you navigate the space and will provide residents access to driveways when required.

Work hours will be from 7am to 5pm weekdays and there may be some noise and dust from construction activities during this time. All noisy works will be completed in intervals of work and respite, and there will be noise and dust monitors installed to help minimise impacts where possible.

To minimise construction impacts, this package of works has been staged. Stage 2 will require a road closure further down Church Street between Fowler Street and Grose St. We will provide an update and communicate the dates for Stage 2 when they are confirmed.




Figure 3: Works notice phase 2

Works notice: Thursday 20 June 2024 Church Street road closure and detour in place

From Thursday 20 June 2024 there will be a complete road closure on Church Street from Carillon Avenue intersection through to Grose Street for approximately four weeks.

Vehicle access to Church Street and Grose Street will be via Hospital Road and Lucas Street or Mallett Street and Fowler Street. Pedestrian access will be maintained but adjusted at times. Due to insufficient space for a turning circle there will be no street parking available in the closed area. Traffic controllers will be on site to help you navigate the space and will provide residents access to driveways when required.

Work hours will be from 7am to 5pm weekdays and there may be some noise and dust from construction activities during this time. All noisy works will be completed in intervals of work and respite, and there will be noise and dust monitors installed to help minimise impacts where possible.

To minimise construction impacts, this package of works will be done in stages. Stage 2 will require a road closure further down Church Street between Fowler Street and Grose St. We will provide an update and communicate the dates for Stage 2 when they are confirmed.

Key impacts

- Full road closure on small section of Church Street. No access to Church Street via Carillon Avenue.
- Access to Church Street and Grose Street via Hospital Road and Lucas Street or Mallett Street and Fowler Lane.
- No parking on small section of Church Street.




Figure 6: Sorry we missed you flyer
