
Terms and Conditions

Overview

1. By entering the Name the Crane Competition (the Competition), an entrant is indicating his/her agreement to be bound by these terms and conditions. All entrants must have permission from their parent or guardian to enter the Competition.
2. The purpose of the Competition is to name two tower cranes on the Royal Prince Alfred (RPA) Hospital Redevelopment site. Both tower cranes will be given a unique name. There will be a First Place for Tower Crane 1 and Second Place for Tower Crane 2.
3. Entries are open to primary school students who live or go to school in the local area, or whose parents/guardians work at RPA Hospital.
4. The Competition is being run by Health Infrastructure and Sydney Local Health District (Organisers).
5. The Competition closes at 6pm on 14 March 2025. After this date, no further entries to the Competition will be considered.
6. Winners of the Competition will be notified by telephone or email within 21 days of the closing date of the Competition.
7. No responsibility can be accepted for entries not received for any reason.

How to Enter

8. The entry form and Competition details can be downloaded from the RPA Hospital Redevelopment website at rparedevelopment.health.nsw.gov.au or can be requested via email rparedevelopment@health.nsw.gov.au
9. To enter the Competition, entrants are to:
 - Submit a single name for one of the two tower cranes on the worksite;
 - Tell us why you've chosen the name; and
 - Complete your entry details including providing your name, age, suburb, school, and contact details, and have the entry form completed/signed by a parent/guardian.
10. Entrants can email their completed entry form to: rparedevelopment@health.nsw.gov.au
11. Each entrant may only enter the Competition once. Multiple entries from the same person will be disqualified.
12. There is no entry fee to enter this Competition.

Prizes

By accepting the prize, the first and second place winners and runners-up agree to being contacted by the Organisers and attend the official crane naming ceremony (with date to be confirmed), and agree to participate in related publicity activities including consenting to their name, any interview conducted, and photograph being used for publicity material associated with the Competition and the RPA Hospital Redevelopment project. The winners and runners-up also consent to being interviewed and photographed by local media at the official crane naming ceremony.




Judging

17. Judging will be conducted by a panel including a representative from the Sydney Local Health District, a Health Infrastructure representative and a CPB Contractors representative.
18. Entries will be judged on the creativity of the crane's name, including on account of the entrant's age.
19. The judging panel's decision is final and no correspondence will be entered into.
20. Entries which are incomplete, incorrect, offensive, non-serious or incomprehensible will be ruled ineligible.

General

21. The entrant grants the Organisers and CPB Contractors the right to use the name of the crane for the RPA Hospital Redevelopment project.
22. Any personal information relating to the winners, runners-up or any other entrants will be used in accordance with the *Privacy and Personal Information Protection Act 1998*, and will not be disclosed to a third party without the entrant's prior consent.
23. Any transport costs or ancillary costs to attend an official crane naming ceremony at RPA Hospital are the entrant's responsibility.
24. The Organisers reserves the right to cancel or amend the term and conditions of the Competition at any time.
25. Each entry will become the property of the Organiser with no obligation to return any entry to an entrant.
