


# RPA HOSPITAL REDEVELOPMENT

**PROJECT UPDATE JUNE 2023** 



The NSW Government has committed \$750 million to the redevelopment of the RPA Hospital to deliver a new hospital building and refurbishment of existing spaces. It is the biggest transformation of RPA in its 140-year history of caring for our community.

The RPA Hospital has been a respected provider in healthcare and a worldwide leader in innovation since its foundation in 1882. We maintain the philosophy that our doors are always open to those who need our help.

The NSW Government's \$750 million investment into the redevelopment of RPA will see the expansion of trusted services that will enable improved care provision for our patients and community.

## What services will the redevelopment deliver?



Expanded and enhanced Emergency Department and Intensive Care Units



Increased interventional and imaging services



State-of-the-art operating theatres



Expanded neonatal intensive care services



Expanded and improved adult inpatient ward accommodation



Improved public domain and services including roads, wayfinding, landscaping and information and communications technology infrastructure

## Real project advancements

We've had some real project advancements on the RPA Redevelopment. Commenced in November 2022, enabling works have forged the path for the main construction works.

Barpa has been busy building infrastructure that will deliver a range of improvements to traffic movement around the campus. They are also working on refurbishments which will see the relocation of Anatomical Pathology to an expanded and enhanced space. Indigenous engagement is important to the integrated project team, and we were delighted to have a majority Indigenous-owned company, Barpa, provide these works.

Plans are underway for site sheds to be set up for CPB Contractors who have been appointed to finalise plans for RPA Hospital Redevelopment, ahead of main works commencing. We will continue to inform staff and community about upcoming impacts and all works will be well signposted with active traffic management. 

## Down to the details

While enabling works continue, the project team is focused on finalising the detailed design. The final design stage before moving into main works construction, detailed design is department centred and focuses on room inclusions such as furnishing, fittings, equipment and information and communication technology.

During this phase, Health Infrastructure continues to work closely with hospital management teams, staff and patient representatives, taking on feedback to ensure the newly built hospital operates efficiently and continues to provide world-class healthcare to the community.

## Consultation continues on helipad relocation

We continue to consult with our community on the temporary relocation of the Helipad Landing Site (HLS). Following the first consultation in September 2022, the project team took to the streets in early May 2023, to notify and speak with RPA neighbours on the relocation plans.

The relocation will ensure the safety of patients, staff, locals and construction workers while the redevelopment is underway, and will enable the installation and use of construction tower cranes.

Due to the consultation and planning that has gone into the relocation, RPA hospital can continue its mission of world-class delivery of patient care with the support of the temporary helipad.

We aim to manage our work to reduce the impacts on the community and the environment and we thank you for your ongoing feedback, support and guidance to help shape your new hospital.

The enhancement and expansion of arts-in-health and Connecting with Country work will also mean the continued creation of culturally safe spaces, and welcoming environments for all.

How do you ensure staff and community are involved in shaping the future of RPA? I am lucky enough to be part of Project User Groups and Project Working Groups, which ensure a diverse range of voices, from staff to consumers, are able to provide feedback and advice on areas within the redevelopment. ## The importance of the arts in health

The \$750 million RPA Redevelopment is progressing to the next stage of project planning, with independent arts facilitator, Michael Lynch, selected to lead the Curatorium for the Arts and Culture Strategy.

Art is an important component of the project, as it will inform the overall look and feel of the buildings while providing opportunities to explore how arts can help deliver exciting and welcoming therapeutic spaces that nurture recovery.

A Curatorium is a multi-disciplinary approach to the Arts in Health Strategy that relies on a group of different individuals and organisations to help inform the arts outcomes for the RPA Hospital Redevelopment.

With representation from across the hospital and the community, the Curatorium will involve partnerships between health services, arts organisations, and artists to develop and deliver arts programs and strategies for the new build and beyond.

### **Community engagement**

Talking to the community about what they want and need is a vital part of our planning and delivery process that complements our consultation with hospital staff clinicians and consumers.

There are many ways we work to ensure the community, staff, clinicians and consumers are informed and have opportunities to provide feedback and input into this important project. This includes community information sessions, surveys, online meetings, project displays in the hospital foyer, regular updates on our project websites, letter-box drops to our neighbours, and regular e-newsletters.

We continue to work closely with the community, staff, clinicians and consumers to share project information, updates and to ask for feedback. #### Where to next?

Health Infrastructure lodged a State Significant Development Application (SSDA) for the \$750 million RPA Redevelopment in early 2023. This was the result of two years of detailed planning and extensive consultation with clinicians, operational staff, community members and local and state government agencies.

Following lodgement, the Department of Planning and Environment (DPE) publicly exhibited the State Significant Development Application and Environmental Impact Statement. The community was encouraged to review the design and make submissions with feedback.

With the exhibition period now closed, the project team is working with planning consultants to respond to submissions and submit the SSDA for the assessment period.

Once submitted, a report will be produced by DPE that recommends Conditions of Consent and following that will be approval, or determination of the application. For further detail please see our **planning fact sheet**.
